Founded as the Institute of Cost and Works Accountants in 1919


Changed name to Institute of Cost and Management Accountants in 1972

Royal Charter and name change to Chartered Institute of Management Accountants (1986)

Chartered Global Management Accountant CGMA designation (2012)

In 2011, CIMA entered into a joint venture with the American Institute of Certified Public Accountants (AICPA) to launch a global management accounting designation called the Chartered Global management Accountant (CGMA)


What is Management Accounting?
